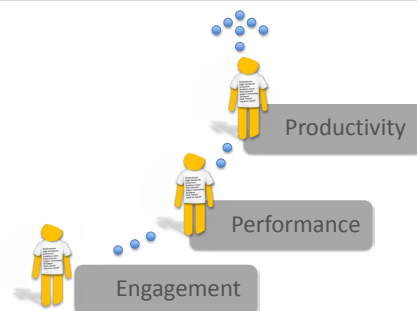
Minding Mindset

In this program, Joanne Schaefer summarized the findings of the ABA's groundbreaking study on attorney well-being. The ABA's study, the first comprehensive analysis undertaken in 25 years, reinforced some results from earlier and smaller studies and at the same time turned other findings and assumptions upside down. Attorneys abuse alcohol and experience mental illness at rates far higher than people in other professions. In addition to summarizing the ABA findings, Joanne provided next steps to address this issue, and discussed its impact on profitability and the reasons why the profession is resistant to change.

PDC Richard Pearson Award Presentation

Award Presented to Michele Bendekovic and Jeanne Picht during Winter Meeting



The Richard Pearson Award was presented on November 30, 2016, at the PDC Winter Meeting held at the Mandarin Oriental Hotel in Washington, D.C. The PDC is pleased to announce the 2016 recipients of the PDC Richard Pearson Award: Michele Bendekovic, director of attorney development and diversity, Bass Berry & Sims, and Jeanne Picht, director, attorney talent & strategy, Fenwick & West LLP.

The Richard Pearson Award was established in 2014 in memory of Richard Pearson, a longtime PDC member and stalwart in the legal professional development community. Pearson, whose previous positions included serving as chief learning & development officer at Davis Wright & Tremaine LLP in Seattle, died suddenly in March 2014 while rowing, one of his passions. Richard served on the PDC Board from 2011 through 2013 and left behind an impressive legacy of innovation and collaboration as a legal PD professional and leader.

This year, the awards committee selected two honorees. Michele Bendekovic received this award for her innovative spirit, commitment to mentoring, and lifelong love of learning. Michele has been involved in attorney professional development and recruiting for over 20 years and has been very active in the Professional Development Consortium, serving as a former board member and former chair of the Membership and Nominating Committees and on several conference planning committees. Michele holds an M.A. in personnel administration and industrial relations from St. Francis University and a B.A.

in history from Indiana University of Pennsylvania. She has completed additional coursework in coaching and project management.

The committee also honored Jeanne Picht, who has more than 20 years of experience in the legal field as a practicing attorney, a consultant to law firms, and as an attorney talent development professional. She is a senior leader in the legal talent development field, serving on the PDC Board of Directors and on the ABA's Law Practice Board of Editors. Jeanne is a frequent speaker and author on the subject of attorney talent development. Jeanne continues to be closely involved with the Indiana University Law School Alumni Board, currently serving as its president. She is a proud graduate of the 2012 U.S. Army War College's 58th Annual National Security Seminar. She is currently studying for her SPHR certification from SHRM.
