To ensure access to conference sessions and events, we recommend that you always wear your badge. Should you accidentally misplace your badge you may pick-up a replacement at the Registration Desk.

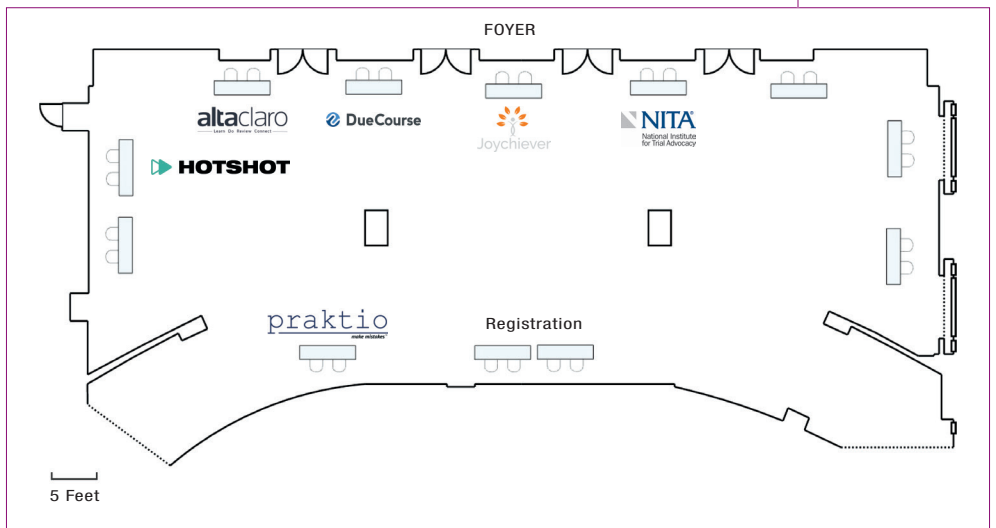
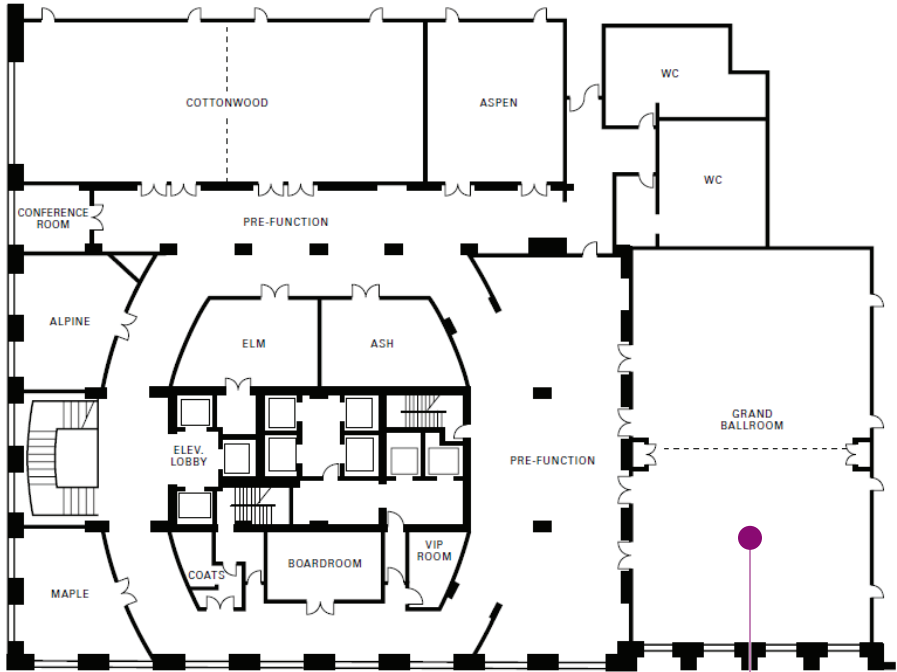
